## Introduction

### Conference Background

The East African Community Conference (EACON) 2024, held from June 24-25, 2024, at the Afisiyooni Tent in Mogadishu, Somalia, was a landmark event signifying Somalia's recent accession to the East African Community (EAC). This conference marked the first time Somalia hosted EACON, reflecting its growing role and commitment within the regional bloc. Organized by SIMAD University and Somali National University, in collaboration with various regional and international partners, and under the patronage of the Ministry of Education, Culture, and Higher Education of the Federal Republic of Somalia, the conference aimed to foster dialogue, collaboration, and integration among EAC member states, focusing on economic growth, trade, education, and environmental sustainability.

The EACON 2024 conference was conceived in the context of Somalia's evolving role within the EAC. Following years of significant political and economic reforms, Somalia formally joined the EAC in January 2023, marking a new chapter in its regional engagement. This

event symbolized the culmination of a decade-long journey that began in 2012 when Somalia first expressed its interest in joining the EAC. The successful integration of Somalia into the EAC underscores the country's resilience and its commitment to regional cooperation, economic development, and collective security.

EACON 2024 aimed to build on these foundations by providing a platform for stakeholders across the region to discuss and develop strategies for deeper integration and collaboration. The conference brought together government officials, business leaders, academics, policymakers, and representatives from various organizations to share insights, discuss challenges, and explore opportunities for regional development. The theme, "Strengthening Regional Cooperation in the East African Community," was chosen to reflect the collective ambition of EAC member states to foster unity, enhance collaboration, and drive sustainable development across the region.



## Objectives and Goals

The primary objectives of EACON 2024 were to:



**Facilitate Regional Integration:** Strengthen Somalia's integration into the EAC by promoting economic cooperation, trade, and investment opportunities. The conference sought to create a conducive environment for discussing policies and frameworks that would enhance regional integration, reduce trade barriers, and promote the free movement of goods, services, and people within the EAC.



**Promote Education and Research:** Encourage academic collaboration and research initiatives to enhance the quality of education and foster innovation within the EAC. The conference provided a platform for universities and research institutions to showcase their work, share best practices, and explore opportunities for collaboration. By promoting education and research, EACON 2024 aimed to build a knowledge-based economy that supports sustainable development and innovation.

EACON 2024 aimed to highlight the economic opportunities available within the EAC, encouraging investments in key sectors such as agriculture, manufacturing, and technology. The conference also aimed to identify and address the challenges faced by businesses in the region, promoting a more competitive and resilient economic environment.



**Address Environmental Challenges:** Develop collaborative approaches to address climate change and environmental sustainability, ensuring a resilient and sustainable future for the region. The conference aimed to foster dialogue on critical environmental issues, such as deforestation, water scarcity, and climate resilience. By promoting collaborative initiatives and sharing best practices, EACON 2024 aimed to enhance the region's capacity to tackle environmental challenges and promote sustainable development.





**Strengthen Diplomatic Ties:** Enhance diplomatic relations among member states,

fostering peace, stability, and mutual understanding. EACON 2024 provided a platform for high-level diplomatic engagement, facilitating dialogue on issues of mutual interest and promoting regional security and stability. The conference aimed to build trust and cooperation among EAC member states, reinforcing the region's commitment to collective security and prosperity.



## Conference Theme and Sub-Themes

Dr. Protas concluded his address by reaffirming the University of Dar es Salaam's commitment to supporting the EAC's development goals through education and research. He called on stakeholders to collaborate and invest in higher education and research to build a prosperous and sustainable future for the region.



## Keynote Address by Prof. Dr. Thoko Kaime, University of Bayreuth

---

Prof. Dr. Thoko Kaime, representing the University of Bayreuth, delivered a keynote address focusing on environmental sustainability and climate resilience within the East African Community (EAC). Prof. Dr. Kaime began by highlighting the urgent need to address environmental challenges and build resilience to climate change in the region.

Prof. Dr. Kaime emphasized the importance of regional cooperation and collective action in addressing environmental issues, such as deforestation, water scarcity, and climate change. He discussed the role of the University of Bayreuth in supporting environmental research and policy development, providing examples of collaborative initiatives with other universities and research institutions within the EAC.

Prof. Dr. Kaime also addressed the need for integrated approaches to environmental management, noting that environmental sustainability is interconnected with economic and social development. He called for policies that promote sustainable

development practices, protect natural resources, and enhance the resilience of communities to climate change impacts.

In addition, Prof. Dr. Kaime discussed the importance of education and awareness in promoting environmental sustainability. He highlighted the role of universities and research institutions in providing education and training programs that equip individuals with the knowledge and skills needed to address environmental challenges. Prof. Dr. Kaime provided examples of how the University of Bayreuth is contributing to this effort through its programs and initiatives.

Prof. Dr. Kaime concluded his address by calling for greater investment in environmental research and education, and stronger partnerships between governments, academia, and civil society. He reaffirmed the University of Bayreuth's commitment to supporting the EAC's environmental goals and expressed optimism about the region's ability to achieve sustainable development through collective action and collaboration.





## Prof. Dr. Idris Ahmada Rai, Deputy Executive Secretary, IUCEA

Prof. Rai discussed the Common Higher Education Area (CHEA) initiative, which aims to harmonize educational standards across the EAC. He emphasized that CHEA will facilitate student mobility, mutual recognition

of degrees, and regional collaboration in research. Prof. Rai positioned IUCEA as a key player in maintaining education quality and accreditation throughout the EAC.



Mr. Tabaro examined the legal and socio-economic requirements for Somalia's EAC membership, drawing from historical treaties and emphasizing Somalia's alignment with EAC governance principles. He concluded by

stressing the importance of harmonizing Somalia's policies with those of the EAC to ensure a smooth transition and mutual growth.

## Key Topics Discussed:

---

- 1. Role of the Private Sector:** John Bosco Kalisa emphasized the importance of understanding the People-Centered and Market-Driven Integration Principles. He explained the four stages of EAC integration: Custom Union, Common Market, Monetary Union, and Political Federation. Kalisa highlighted the need for harmonization and predictable policies to support integration, and he shared insights on how the private sector can drive economic growth and job creation by leveraging these integration stages.
- 2. Support for Small Businesses:** Claudia Voss highlighted the strength of African businesses in Germany and urged the Somali community to integrate with other businesses in East Africa. She noted that Somalia's inclusion in the EAC is a significant step forward with substantial future opportunities. Voss emphasized the importance of networking and building relationships with businesses across the region to create a more robust and resilient economy.
- 3. Impact of Climate Change:** Ms. Jacinta Kiruthi discussed the EAC's role in addressing climate change through collective action and shared responsibility. She emphasized the importance of policy alignment and regional cooperation in combating climate change, noting that environmental sustainability is crucial for long-term economic stability and growth. Kiruthi also highlighted initiatives aimed at reducing carbon emissions and promoting green technologies.
- 4. Market Penetration Strategies:** Mrs. Silvia Befghof emphasized the importance of having the right product, involving the community in business projects, and partnering with like-minded institutions to penetrate bigger markets. She shared successful case studies of companies that have effectively entered new markets through strategic partnerships and community engagement.

## Outcomes and Recommendations:

---

- **Policy Harmonization:** The panel recommended the harmonization of trade policies and regulations across EAC member states to facilitate seamless trade and investment. This includes standardizing customs procedures and reducing non-tariff barriers.
- **Infrastructure Investment:** Increased investment in infrastructure, particularly in transport and logistics, was identified as a priority to support cross-border trade. The panel emphasized the need for modern ports, roads, and railways to enhance connectivity and reduce trade costs.
- **Capacity Building:** The panel stressed the need for capacity-building programs to enhance the skills and knowledge of traders, policymakers, and investors. This includes training on international trade standards, market research, and business management.
- **Leveraging Technology:** Embracing digital technologies and innovative solutions was highlighted as crucial for improving trade efficiency and expanding market access. The panel encouraged the adoption of e-commerce platforms, digital payment systems, and trade information portals.

## Panel 2: Building Bridges through Knowledge: Enhancing Academic Collaboration in the East African Community

The second panel discussion emphasized the role of academic collaboration in fostering regional integration and development within the EAC. The discussion highlighted how

shared resources, collaborative research projects, student and faculty exchanges, and internships will strengthen ties and foster innovation across member countries.

## Key Topics Discussed:

---

1. **Student Exchange Programs:** Prof. Dr. Abdishakur Sh Hassan discussed the benefits of student exchange programs in fostering educational integration, cultural experiences, and research collaboration. He highlighted that Somali students can participate in cross-institutional academic competitions due to their proficiency in English and Kiswahili. Exchange programs also promote mutual understanding and build networks among future leaders in the region.
2. **Policy Considerations for Integration:** Abdullahi Ibrahim stressed the importance of establishing rules and frameworks internally in Somalia to align its higher education system with the EAC. He emphasized the need to address political aspects and

collaborate with EAC member states. Ibrahim discussed the potential of integrating regional education policies to create a more cohesive academic environment that supports mobility and recognition of qualifications.

3. **Future Opportunities for Academic Collaboration:** Panelists highlighted the potential for research collaboration, addressing the scarcity of public schools and higher education institutions in Somalia, and the importance of enhancing the education system to foster collaboration with EAC countries. They discussed initiatives such as joint research projects, academic conferences, and collaborative online learning platforms.

## Outcomes and Recommendations:

---

- **Cross-Border Internships:** The panel discussed the importance of facilitating cross-border internships for students to enhance employability and institutional coordination for seamless integration. Internships provide practical experience and exposure to different working environments, which are valuable for students' professional development.
- **Awareness Initiatives:** Emphasized the need for awareness initiatives to promote cross-border opportunities and exchange programs within the

EAC. This includes information campaigns, seminars, and workshops to inform students and faculty about available programs and opportunities.

- **Scholarships:** Encouraged providing scholarships for students to study abroad, enhancing their educational experiences and regional integration. Scholarships can support talented students who may not have the financial means to pursue higher education opportunities outside their home country.

### Key Topics Discussed:

1. **Adaptation to Climate Change:**  
Ahmed Yusuf discussed the importance of harmonizing existing regulations and laws, sharing best practices, and coordinating responses

during climate emergencies. He emphasized the need for joint training programs and the creation of a reliable EAC database. Yusuf highlighted the role of regional cooperation in

enhancing the capacity of member states to adapt to climate change impacts.

2. **Policy Harmonization:** Abdilatif Hussein Omar highlighted the need for coordinated information-sharing platforms, harmonized adaptation strategies, and community involvement in policy design. He stressed the importance of developing climate-resilient infrastructure and sustainable farming solutions. Omar discussed the benefits of aligning national policies with regional and international standards to create a cohesive approach to environmental management.

3. **Role of Civil Society and Academia:** Panelists discussed the role of civil society organizations and academia in addressing climate change challenges through public awareness campaigns,

evidence-based research, and collaboration with policymakers. They highlighted successful examples of community-led initiatives and academic research that have informed policy decisions and promoted sustainable practices.

4. **Sustainable Community Solutions:** Abbass Kassim emphasized the importance of community-driven policy solutions, alternative energy generation, and incorporating environmental studies into the school curriculum. He highlighted the need for protected grazing areas and mutual support among neighboring member states during climate emergencies. Kassim discussed innovative approaches to engaging communities in environmental conservation efforts, such as participatory planning and capacity-building programs.

## Outcomes and Recommendations:

- **Investment in Green Technologies:** Encouraged investment in green technologies and infrastructure to enhance climate resilience and sustainability. This includes renewable energy projects, energy-efficient technologies, and sustainable agricultural practices.
- **Education and Awareness:** Highlighted the need for integrating environmental education into the school curriculum and conducting public awareness campaigns on environmental sustainability. Education and awareness initiatives can foster a culture of environmental stewardship and empower individuals to take action on climate change.

## Panel 4: Beyond Membership: Somalia's Legal Transformation for EAC Integration

This discussion explored the legal adjustments required for Somalia to align with EAC frameworks. The panel, moderated by Mr. Said Omar Bashir, opened with an overview of the EAC's history, structure, and its four foundational pillars essential for

integration: Customs Union, Common Market, Monetary Union, and Political Confederation. These pillars, he emphasized, are the foundation of EAC's growth and regional cohesion

## Key Topics Discussed:

Political Confederation:** Dr. Idd Ramadhani Mandi explained that a political confederation is a union of sovereign states with the right to withdraw and a decision-making process based on consensus. He outlined the progress toward EAC's federation, including the adoption of several key protocols.
- 2. Integration Strategy:** Prof. Dr. Alexander Stroh-Steckelberg highlighted the adaptability of the EAC legal framework to accommodate Somalia, suggesting provisions for Somali judges in the EAC court and emphasizing the need for political goodwill.
- 3. Legal Reforms for Business:** Awv. Abdulkadir Mohamed Tahlil recommended legal reforms, such as creating a competition act and aligning business laws with EAC standards, to attract investors and support Somalia's business environment within the EAC.
- 4. Institutional Capacity:** Prof. Abdulkadir Yusuf proposed that Somalia's parliament establish nine committees to facilitate EAC engagement, encouraging youth participation for meaningful contributions in the integration process.

## Outcomes and Recommendations:

---

- The panel concluded with a call for Somalia to actively engage with EAC stakeholders, especially within the business community, and for Somali youth to seize opportunities within the EAC framework.

**Presentation by Dr. Mohamed Ibrahim Nor, Senior Fellow, ICE Institute**

Dr. Mohamed Ibrahim Nor, a renowned academic and researcher, presented his paper on the role of innovation and technology in driving sustainable development within the

EAC. His research focused on the critical role that technology plays in enhancing productivity, fostering innovation, and promoting environmental sustainability.

**Key Points from the Presentation:**

- 1. Technological Innovation:** Dr. Nor highlighted the potential of technological innovation to transform key sectors such as agriculture, manufacturing, and services. He provided case studies of successful technological interventions in other EAC member states and discussed their applicability to Somalia.
- 2. Digital Economy:** The presentation explored the growth of the digital economy within the EAC, emphasizing the importance of digital infrastructure, e-commerce, and mobile money platforms. Dr. Nor discussed how digital technologies can enhance access to markets, improve financial inclusion, and support economic activities.
- 3. Sustainable Development:** Dr. Nor focused on the role of technology in promoting environmental sustainability. He discussed innovations in renewable energy, sustainable agriculture, and waste management, providing examples of how these technologies can mitigate the impacts of climate change and support sustainable development goals.

4. **Collaboration and Partnerships:** The paper emphasized the importance of regional collaboration and partnerships in fostering innovation. Dr. Nor called for greater cooperation

between governments, the private sector, and academia to create an enabling environment for technological innovation.

### Recommendations:

### Presentation by Juweria Mohamed Ibrahim, Visiting Researcher, ICE Institute

Juweria Mohamed Ibrahim, an influential researcher and advocate, presented a paper on the economic impacts of regional integration within the East African

Community (EAC). Her research focused on the transformative potential of Somalia's recent accession to the EAC and the expected economic benefits and challenges.





## Key Points from the Presentation:

---

1. **Economic Growth Potential:** Ibrahim highlighted that regional integration is expected to significantly boost Somalia's GDP by facilitating access to a larger market and enhancing trade opportunities. She provided data-driven projections on how reduced trade barriers and increased foreign direct investment could stimulate economic growth.
2. **Sectoral Opportunities:** The presentation identified key sectors that stand to benefit from regional integration, including agriculture, manufacturing, and services. Ibrahim emphasized the need for targeted policies to support these sectors and leverage regional value chains.
3. **Challenges and Mitigation Strategies:** Ibrahim discussed potential challenges such as competition from more developed economies within the EAC, infrastructural deficits, and regulatory alignment. She proposed strategies to mitigate these challenges, including capacity building, infrastructural investments, and gradual policy harmonization.

Ibrahim advocated for policies that support small and medium-sized enterprises (SMEs), women, and youth.

- **Inclusive Growth Policies:** Implement policies that support SMEs, promote gender equality, and create opportunities for youth.

### Remarks by H.E. Amb. Hon. Kubai Iringo, High Commissioner of Kenya to Somalia

H.E. Amb. Hon. Kubai Iringo, the High Commissioner of Kenya to Somalia, delivered a detailed and inspiring speech focusing on the crucial role of diplomatic engagement

and regional cooperation in achieving sustainable development within the East African Community (EAC).



### Key Points from the Remarks:

- **Regional Stability and Security:** Ambassador Iringo emphasized the importance of peace and stability as foundational elements for economic growth and regional integration. He highlighted Kenya's commitment to working with Somalia and other EAC member states to address security challenges such as terrorism, piracy, and cross-border conflicts. The ambassador underscored the need for a collective security approach, involving intelligence sharing, coordinated military efforts, and community engagement to ensure a stable and secure region.
- **Economic Integration and Trade Facilitation:** The High Commissioner discussed the potential for increased trade and investment within the EAC, particularly in light of Somalia's recent inclusion. He stressed the importance of harmonizing policies and regulations to facilitate cross-border trade, reduce non-tariff barriers, and streamline customs procedures. Ambassador Iringo also highlighted successful trade agreements and partnerships that have bolstered

economic cooperation among member states.

- **Infrastructure Development:** Ambassador Iringo pointed out the critical need for infrastructure development to support trade and economic activities. He called for joint investments in transport networks, including roads, railways, and ports, to enhance connectivity across the region. US diplomatic efforts in supporting democratic institutions and processes within the EAC member states. Ambassador André highlighted successful examples of democratic transitions and governance reforms in the region.

- **Environmental Sustainability and Climate Action:** Addressing environmental challenges, Ambassador André highlighted the need for collective action to combat climate change and promote environmental sustainability. He discussed US initiatives aimed at supporting climate resilience and sustainable resource management in East Africa. ## Remarks by H.E. Amb. Claude Morel, High Commissioner of Seychelles to Kenya

H.E. Amb. Claude Morel, the High Commissioner of Seychelles to Kenya, delivered remarks focusing on the unique challenges and opportunities faced by island nations within the EAC framework.
